I have recommitted to my engagement in volunteerism and am beginning an active search for a Board seat in our local community. I support individual expression in my household with my teen children and have done my best to model open-minded, community-centric, honest values. I am also engaging my own organization to hold us accountable to having the critical conversations needed to move our organization toward a more Diverse, Equitable and Inclusive culture, and to providing a safe environment for my team and peers to raise issues that need attention. I enjoy your programming and have become much more aware and educated on topics of all levels through your content; I am an avid listener of the Abe and Joe show, Democracy Now! with Amy Goodman and Juan Gonzales, and the show previously hosted by the esteemed, now-Commissioner Jo Ann Hardesty. I have also enjoyed evening programs hosted by our local tribal community members and Leaders. I hope this essay conveys my relevant experience for and interest in the KBOO board seat. I hope my values and experience align with what you are looking for and can bring contributions to the KBOO foundation. I value your search for a diverse board and hope I am a fitting piece to your tapestry.
