## 4 Exec Com Report Electrical Update - Jill

### 10min

- Rose City Electric
  - Rose City Electric gave the first bid of \$12,000 for grounding and electrical panel work.
  - They also submitted a bill to KBOO for \$2,800 for consultations with the City and a permit.
    - KBOO is refusing to pay for these services as the other electricians were able to provide quotes without permits and without charge.
- Ertell's Electric
  - Quote = \$8,200 for grounding work
- Mr. Electric
  - $\circ$  Quote = due Tuesday, 5/24/2022
- Badger Electric
  - Ouote due week of 5/23/2022

### **Property Donation - Brian and Delphine**

A member passed away and left a piece of property to KBOO.

- KBOO needs to work with a real estate attorney to transfer the title
- The property is currently worth approximately \$580K
- The house is a rental and currently has renters
- A committee has been formed to determine what to do with the property.
  - Become property managers?
  - o Sell
    - Invest money in new equipment
    - Rehab KBOO building
    - Move?

### Final days of Spring Drive - Jill & Delphine

- KBOO has about \$40K in of \$56K goal with 6 days remaining

### **Recommendation from Engineering Com - Jill**

- Purchase and install a Nautel GC15 HD transmitter to be KBOO's main transmitter on 90.7.
- 20+ lead time
- Total purchase = \$113,150
  - \$93,150 = Transmitter + additional parts + shipping
  - $\circ$  \$20,000 = Installation

### **Development Committee - Jill**

- This highlights the importance of aggressively seeking syndication up and down the West Coast and across the country.

### **Nominating Committee - Ruba & Jill**

- Ruba shared Malik's message that The Clinton Street Theater is under new management.
  - They are requesting a formal underwriting proposal along with the request for space for KBOO's annual meeting.
